2	MACSF	NEW EUROPE	COLREGs replaced RRS in chapter 2 at the moment of the crossing. As the potack boat (wind on the port side), NEW EUROPE failed to keep out of the woof MACSF. Infringement SI 11.1.1 is a range 1 penalty (0h-6h). Any answers the questions in Appendix 6 do not justify any decrease and any increase in the penalty time. The jury decided to impose the average penalty of range 1.	y A time penalty of 180 minutes is imposed on NEW EUROPE. This penalty shall be taken
3	Technical Committee	Singchain Team Haikou	In deciding the penalty, the jury used SI 11.2.1 and Appendix 6 to apply the Jury's power of discretion, noting that: With the accidental filling of this forward ballast,, the boat is no longer to compliance with the IMOCA class rules. The breaking of the lead laid by the class was necessary in order to empty the water and remain as much as possible within the stability measures imposed be its measurement certificate. The skipper pumps regularly to empty the water in this ballast. There is not a reasonable opportunity to fix this problem to avoid water filling in this ballast. The jury applies RRS 64.4 (a) "Decisions on Protests Concerning Class Rules and SI 11.2.2 Discretionary power of the Jury.	The Jury decides not to give a penalty. The skipper must do everything possible to sail with this empty ballast for reasons of stability.
4	Technical Committee	HUMAN IMMOBILIER	To safely anchor in the lee of the Saint-Paul Island Human Immobilier had a use her engine and anchor, breaking both seals. She broke SI 16.3.1 and S 16.3.2. Human Immobilier used the engine for 0.6 nautical miles. She broke RRS 42. Human Immobilier was not able to retrieve her anchor and had to cut it free Therefore she did not break RRS 45. However, the boat now no longer complie with the requirement of CR 3.21(a) to have two anchors on board. In deciding the penalty, the jury used SI 11.2.1 and Appendix 6 to apply the Jury's power of discretion, noting that: There is a good reason or justification for the breach. The breach was reported immediately by the boat. The breach was not advantageous to the boat. Any answers to the questions in Appendix 6 do not justify an increase in the penalty time. The jury has decided to judge this as a single incident and impose a penalty lest than the average of range 2	A time penalty of 180 minutes is imposed on HUMAN IMMOBILIER. This penalty shall be taken according to SI 11.5

6	6	Technical Committee	L'Occitane en Provence	The skipper warned the RM that she had accidentally broken the seal of the grab bag. Infringement of SI 16.3.2	L'Occitane en Provence accepts standard penalty according to SI 11.4. 60 minutes penalty time to take when racing (SI 11.5)
7	7	Technical Committee	Singchain team haikou	The TC noted at the finish that the seal in the position of the water safety container had been accidentally broken. Infringement of SI 16.3.2	Singchain team haikou accepts standard penalty (60 minutes) according to SI 11.4 This penalty will be added to the race time.
